## MPO Performance Management Activities Reminder - PM1, PM3, Transit Safety

- Safety (PM1)
  - MPO safety target setting for 2017-2021 are due by February 27, 2021.
- Freight reliability (PM3)
  - State adjusted two of the State's PM3 targets and any MPOs (except MAPA) that supported State targets will have to reaffirm support or adopt their own targets by March 29, 2021
- Large urban transit systems (5307 recipients) are required to approve their PTASPs by December 31, 2020
  - MPOs should be in contact with their transit agencies regarding when they approved or will approve their PTASP; transit agencies should provide their MPO a copy of the plan, including targets
  - MPOs are required to set their initial transit safety targets no more than 180 days after receipt of the agency safety plan from public transportation providers (Documentation of MPO targets needs be transmitted to Systems Planning)
  - MPO TIPs and LRTPs that are amended or adopted after July 20, 2021 need to include transit safety performance measure and target information.

# Non-Metropolitan Local Officials Consultation Update

- 23 CFR 450.210(b) requires that each state must address (every 5 years) the effectiveness of their process for cooperating with nonmetropolitan local officials as it relates to the statewide transportation planning process (Statewide LRTP and Statewide TIP).
  - A draft copy of Iowa DOT's documented process, and in turn the beginning of its no less than 60-day required solicitation for comments, was distributed on October 26, 2020 to all media contacts, RPA's, League of Cities, ISAC, and cities and counties via Local Systems Bureau.
  - Comments are due December 31, 2020 and a copy of the final documented process is due February 24, 2021 to FHWA and FTA .
  - The final copy of the process will be available on our website.
